

In exercise of powers conferred by Sec.27 of the RTI Act, 2005, the Government of Bihar is pleased to make the following amendments in the Bihar, Right To Information, Rules, 2006.

Amendments

1. (3) (i) A person, who desires to obtain information, shall make an application in Form 'A' accompanied with the prescribed fees, or through the E- medium, to the Public Information Officer or designated Call Centre. The receipt of the application shall be given to the applicant in Form 'B'. The fees may be paid in cash, wherever, facility for cash receipt is available, otherwise, by demand draft or by pay order or in the Form of non-judicial stamp or electronically enabled medium.

- 3 (2) (ii) The Public Information Officer shall inform the applicant in Form 'C' regarding other fees and charges to be paid as determined by the Government, wherever, applying through electronically enabled medium the payment may also be made through electronically enabled medium or any other mode of payment specified under Rules.
2. This notification shall come into force with effect from the date of issue.
