Patna-15, Dated 24/5/13

In exercise of powers conferred under section-27 of the Right to Information Act, 2005 (Central Act, 22, 2005) Govt. of Bihar makes the following Rules to amend the Bihar Right to Information Rules, 2006 [as amended from time to time):-

1. Short title, extent and commencement — (1) These Rules may be called the Bihar Right to Information (Amendment) Rules, 2013.
(2) It shall extent to the whole of State of Bihar.
(3) It shall come into force with immediate effect.

2. Substitution of Rules-6 (2) of the Bihar Right to Information Rules, 2006:-
Rule-6 (2) of the said Rules, 2006 shall be substituted by the followings:-


"(2) The applicant aggrieved by an order of the appellate authority under sub-rule (1) may prefer the second appeal to the State Information Commission within ninety days from the date on which the decision should have been made or from the date of receiving the order giving following details:-

- (i) Name and address of the applicant;
- (ii) Name and office address of the public Information officer;

- (iii) Number, date and details of the order against which the Second Appeal is filed, if any;
- (iv) Brief facts leading to Second Appeal;
- (v) Grounds for Appeal;
- (vi) Verification by the appellant;
- (vii) Any information which Commission may deem necessary for deciding the appeal;

provided that the State Information Commission as the case may be, may admit the appeal after the expiry of the period of ninety days, if it is satisfied that the appellant was prevented by sufficient cause from filling the appeal in time. "




