- **4.** Notwithstanding anything contained in this order, Special Mention for Fast Tracking of appropriate cases will continue to be made before the Hon'ble SCIC, in accordance with the earlier order on the subject, irrespective of the Department with which such matters relate to.
- **5.** Notwithstanding anything contained in this Order, the Hon'ble SCIC will continue to have absolute and unfettered discretion to transfer already registered cases, or newly registered cases, from one SIC to another SIC and/or from the SCIC to any of the SICs and/or vice-versa, either suo motu, or on a specific request by any of the SICs, or on a deviation being brought to the notice of the Hon'ble SCIC by the Secretary-cum-Registrar of the BIC.
- **6.** If any doubt arises as to which Department/Public Authority a particular case belongs to, the Secretary-cum-Registrar of the BIC shall obtain the orders of the Hon'ble SCIC and his order shall be final and binding.
- **7.** The Scrutiny Branch and the Registry of the BIC shall ensure listing of newly registered cases in accordance this Order and any ex-facie deviation shall be brought to the immediate notice of the Hon'ble SCIC.
- **8.** The BSIC (Management) Regulations, 2007 stands modified to the extent indicated hereinabove.
  - 9. This Order shall come into force with immediate effect.
  - 10. This issues with the approval of the Hon'ble SCIC.
